SECTION 4: FIR	RST AID MEASURES

Nervous system effects typical of pyrethroids (motor incoordination, gait abnormalities) in a range of repeated dose studies (dog and rat). Possible

nerve fiber degeneration in 14-day study in rats.

An epidemiological study was conducted which included 165 precipitated silica workers who had been exposed an average time span of 8.6 years. Of these 165 workers, 44 had been exposed for an average of 18 years. No adverse effects were noted in complete medical examinations (including

chest roentgenograms) of these workers

Mutagenicity: Cypermethrin was not mutagenic or genotoxic in a battery of in vitro and in

vivo tests.

**Reproductive Toxicity:** Cypermethrin caused reproduction toxicity in a two-generation study in rats

only at dose levels also toxic to the parent animals. The reproduction toxicity

seen with Cypermethrin is related to parental toxicity.

**Neurotoxicity:** Cypermethrin caused neurobehavioral effects and/or neuropathological

changes in animal studies.
